The Brandon Area Rescue Squad proudly serves the towns of Brandon, Goshen, Forestdale, Leicester, and Sudbury's Emergency medical Services and Ambulance needs and has been for the past 41 years! Brandon Rescue responded to more than 700 calls for help last year. Brandon Rescue is licensed by the Vermont Department of Health at the Paramedic level, the highest prehospital level of care available in the state, and staffed with more than 35 volunteer members, one full time Chief and one part time paid staff member. Brandon Rescue operates a fleet of three state of the art ambulances from a station on the south end of the town on Route 7.

In addition to 24 hour emergency ambulance service Brandon Rescue offers several prevention and educational programs and opportunities. These include:

CPR/AED Training

First Aid training

Entry level Prehospital Training Programs
